SICK ABSENCE AND PAY



If you are unable to come to work due to sickness on a day you would normally work, you must contact your line manager as early as possible (preferably before you are due to start work). You will need to complete a Self Certification Form for any absence up to 7 days and provide a Fitness Note from your doctor on a regular basis for any absence after this. You may be entitled to Statutory Sick Pay although this is not payable for the first three days of absence and is dependent on your earnings as a part-timer. Please refer to the Employment Handbook. You are eligible to occupational sick pay after completion of your probationary period subject to compliance with the absence reporting and medical certification rules in the Employment Handbook.
